ONE PLAN – PROPOSED PLAN CHANGE 2 – EXISTING INTENSIVE FARMING LAND USES

Any appeal on this decision must be in the prescribed form (Form 7, Resource Management (Forms, Fees and Procedure) Regulations 2003) and lodged with the Environment Court and served on Horizons within 30 working days of this notice being served on you. Furthermore, within five working days of lodging an appeal, you are required to serve a copy of the appeal on every person who made a submission on those provisions or matters to which your appeal relates.
